2. The HKTDC Hong Kong Watch & Clock Fair and Salon de TIME 2025 are open for business visitors aged 18 or above only.
3. Exhibitors of HKTDC Hong Kong Watch & Clock Fair and Salon de TIME 2025 are not eligible for the hotel sponsorship programme.
4. If your company or you have applied for Travel Reimbursement or any other buyer sponsorship programmes of concurrent fair, this application will not be processed.
5. Each company is entitled to only one room at one hotel from 2-6 September 2025 (inclusive). This offer is available on a first-come-first-serve basis and subject to room availability.
6. If the choice of hotel is fully booked, HKTDC will designate a hotel to the applicant.
7. 6. Applications without attaching a photocopy of the applicant's business card will not be processed. The hotel will levy at least one-night room charge on your credit card if you do not show up on the specified date.
8. Once your application has been approved, we will send the acknowledgement letter to you within 4 working days. If you do not hear from us within 4 working days, your application is considered as unsuccessful.
9. You must show up at the Fair, complete a questionnaire and collect customised stamps from the "Buying Mission Service Counter" in order to be qualified for the incentive. **Only 1 stamp can be collected on each fair day.**
10. **The original copy of the acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.**
11. HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of disputes over this sponsorship programme, the decision of HKTDC shall be final and binding.
