6. Each company is entitled to ONLY ONE OFFER OF TRAVEL REIMBURSEMENT. This offer is available on a first come, first served basis.
7. If your company information is not the same as on the travel reimbursement application form; or the company information provided is incorrect, HKTDC reserves the rights to void this sponsorship without prior notice. Any expenses incurred will be settled on your account.
8. Your company information and personal particulars must be identical to the information on your application form, business card and passport.
9. You must show up at the designated fair and complete a buyer survey when collecting the Travel Reimbursement Voucher at the "Buying Mission Service Counter". The person collecting the Voucher and the stamps must be the same person applying for this programme.
10. Applications without attaching a photocopy of the applicant's business card will not be processed.
11. Your application is subject to review by HKTDC. Once your application has been approved, we will send the acknowledgement letter to you within 5 working days.
12. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
13. The HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
